



Crystal Lagoons technology can use any type of water: freshwater, brackish water, and seawater, with operational lagoons around the world, using all these different water types.

Compared with a golf course, our turquoise lagoons offer a higher usage ratio of gallons of water per person. More people can enjoy the beach and a body of water, versus the limited number of sportsmen that use a golf course, creating a recreational venue for the whole family.
